# PRESIDENT'S REPORT

# To the committee and members of the Clyde Tennis Club

As I write this report, the world is in the grip of a pandemic that has changed our lives and the way we go about our day to day activities. Right now, the Melbourne Metropolitan region is in the middle of a second lockdown for six weeks and this has had a huge impact on our movement around the community and certainly around our club. We are grateful that Tennis can continue with restrictions. The committee have been holding regular impromptu meetings (online - our new normal!) as needed to address the changing restriction information from our governments, sporting, and tennis governing bodies. This information is then broken down to club level and decisions made about how we comply and give our members every opportunity to play tennis. This has not been easy, and we thank our members, social players and especially our coaching panel for working with us to ensure we are operating within these guidelines. All our lives have been impacted to varying degrees and many businesses have found the circumstances too challenging. All this on the back of the horrendous bushfires at the beginning of the new year has made for tough times particularly in south east corner of our country. Tough times indeed.

I would like to make special mention here and thank our club secretary Varuni Singh, who has been tireless in her efforts to keep us all up to date with the day to day changes regarding Covid 19. She has been a strong administrator in making sure the club acts in the most professional way with accurate information and application to task, while juggling her own home life, work life and home schooling. A relatively thankless role but she has not waivered and I thank her on behalf of the committee. She has been an invaluable asset, particularly over this period. Thanks Vee!

The year has been full of highlights once again and our annual Hartleigh Tennis Racquet day was once again a big success in November with a great turnout and nice weather as well. A big thanks to our major sponsor National Pacific Properties (NPP) who continue to support our club and community. We are extremely fortunate to have them on board and hope to continue our relationship for a long time to come.

During the Australian Open, Tennis Australia launched "Open Court Sessions" to get people new to tennis involved in a social and fun environment with like-minded people. The program ran for 90 minutes each week over 10 weeks followed by a bite. On court sessions included different types of tennis activities: mini nets and paddles through to a three-team match where players on a rotation basis. Tennis Australia provided the kit. It proved to be quite a success as we had good numbers weekly, with online registrations. Some came back for a regular hit with our Tuesday night social group. Thanks to Varuni once again who coordinated the online bookings and ran the supper, changing the cuisine to make it interesting for those had come back a few times. Overall, a big success in introducing not only newcomers to tennis, but also others that had played at junior level and wanted to reacquaint themselves with the game. We hope to be back once Covid 19 takes a back seat.

The Family Challenge was again a big success with a great turn out and an added side competition of mini golf organized by Cameron Smith, added to our fundraising to take us up to \$1000 which was donated to the Clyde Fire Brigade to fit with the bushfires tragedy in January. Newcomers Team Stinziani were unable to take the points on the day from the well-oiled Team Morris and tight finish kept everyone's interest up. Once again, a terrific job in organising the event by Vaughan Smith, who came up with the original concept and is fast building it to a staple on the calendar each year. Great work and great for the club to be able to give back to our community each year, where it is needed.

Unfortunately, due to the restrictions that were imposed in the initial Covid 19 lockdown, we had to postpone our 40-year birthday celebration which was planned for March. This will be back on once we are clear on what we can safely run and is an important event for recognizing the many people who have contributed in so many ways since inception and the milestones achieved along the way. When you look around now it's hard to believe that this all began as a couple of asphalt courts in the middle of farmland started by a few locals who thought it might give the community somewhere to enjoy a bit of tennis. We will keep you posted on the details for the rescheduling once we know them.

Our Tuesday night social hit has been as popular as ever and continues to pull in strong numbers of likeminded players who enjoy the atmosphere. We were "down" for a short period as the club was in lockdown but have begun again, led by Ken Blencowe, who has had to brave the cold as we reopened and could not use the clubrooms. Our thanks as always go to Ken and his passion for the club.

The last half of the year has certainly been a challenging time for our coaching panel and the off again on again nature of the restrictions and the changing information from governing tennis bodies and local council coming through has made it almost impossible to run a coaching business. I would like to thank Paul and his team for their perseverance and willingness to adapt in trying times.

Our membership numbers have been on the rise consistently over the last two years. Initiatives like pairing with major sponsor NPP to offer memberships to new residents in our local community and the implementation of our online book a court tool, have opened our club to new players that we previously would not have been able to reach. The "Book a Court" online booking facility



had commence being active when Covid 19 started to become an issue in our community early March. We are pleased with the way the system has performed and it is giving our club greater exposure to both club members and members of the wider community, enabling access to both courts and lights, not available before. I would like to acknowledge Tennis Victoria as well as the City of Casey and our major sponsor NPP for enabling us to implement this system through their generous funding initiatives.

As the local area grows the recreation reserve is in use by more and more people and community groups. In the next few years there will be some major changes to the Clyde Recreation Reserve. The City of Casey have engaged the Clyde tennis club and other facility user groups in their planning and while the eventual

changes will close the door on one era of the club it will open a new and exciting stage that embraces the changes in our local area.

Lastly, I would like to thank our committee for their time spent, particularly this last four to five months, trying to give our members as close to "normal" a membership as has been possible. You, the members, have a strong group of caring people who all volunteer their time to provide you with a first-class facility and associated tennis services and ask for nothing in return. I urge any of you who would like to be involved to come along to our committee meetings to get and understanding of how the club is run and perhaps lend a hand or have a voice that helps us to better understand our memberships wishes.

Thanks to all of you for being a part of our club and making it the great place it is to enjoy tennis.

## TREASURER'S REPORT

### **Financial Summary**

The final FY20 result was a surplus of \$4,839 (FY19: \$13,412), down due to one off receipts and the Club's contribution towards the Book a Court (BAC) investment in January 2020.

Total Memberships Funds have decreased by 11% to 23% (102) and is attributed to lockdown restrictions for COVID 19 closure, from March to June (approx. 12 weeks).



We have had a 100% conversion rate to memberships from BAC bookings in June with Return to Tennis.

At the start of FY20, our sponsorship with NPP was renewed for a further 24 months, the funding from NPP continued, which represents 53% of revenue and has enabled the Club to weather the COVID19 environment.


The Club also received grants from the City of Casey for lighting repairs. We also acknowledge the financial support that the council and Tennis Victoria has provided through grants - \$24,000, to enable the Club to implement BAC.

Majority of our expenses has been contributed to court lighting repairs, cleaning of all six courts and the ongoing cleaning and general maintenance. Electricity costs are down by 54% from FY19 again attributed to the Covid19 shut down for both coaching and night tennis.

Our cash reserves remain healthy which is sufficient for the dayto-day operation of the club.



# INDEPENDENT AUDITOR'S REPORT

### **Auditor's Report**

#### **Opinion**

We have audited the accompanying financial reports of Clyde Tennis Club (the Association) which comprises the Statement of Income and Expenditure and the Bank Reconciliation.
